## ***Energize NY***

### *Long-Term, Low-Cost Financing for Energy Saving Improvements*

Energize NY (a NY State, non-profit, Local Development Corporation) provides commercial building owners and not-for-profits with affordable PACE (Property Assessed Clean Energy) financing for up to 100% of the cost of energy efficiency and renewable energy projects. Not-for-profits and owners of affordable housing facilities can take advantage of even lower interest rates through an Energize program supported by Westchester County.

PACE financing is not a bank loan and differs from traditional loans because:

- eligibility is not based on traditional credit scores
- financing is available for up to 100% of the project for terms up to 20 years
- the financing is repaid through an annual charge on the property tax bill

Applying for Energize NY PACE financing is easy, with an online application, fast approvals and customer service to help you through the process.
